1 Items We Accept

Documents

All personal and business documents, including certificates, contracts, and official papers.

Clothing & Apparel

- Underwear and intimate wear
- Scarves and accessories
- Socks and hosiery
- Shirts, blouses, and tops
- Pants, jeans, and trousers
- Dresses and skirts
- Jackets and outerwear

Portable Electronic Gadgets

- Laptops and notebooks
- Tablets and e-readers
- Cell phones and smartphones
- MP3 players and music devices
- Chargers and power adapters
- Bluetooth speakers and headphones
- Earphones and earbuds

Health & Beauty Products

- Hearing aids and medical devices
- Makeup and cosmetics (*sealed, transparent containers*)
- Skin care products (*sealed, transparent containers, no hemp*)
- Hair care products (*sealed, transparent containers, no hemp*)
- Personal hygiene items

Fashion Accessories

- Handbags (clutch-sized, crossbody)
- Wallets and card holders
- Sunglasses and eyewear
- Scarves and wraps
- Belts and buckles
- Shoes (strappy styles preferred)
- Hats (caps, berets, headwear)
- Costume jewelry (avoid fine jewelry)

Portable Appliances

- Coffee makers and espresso machines
- Juicers and blenders
- Can openers and kitchen tools
- Small electronics

Portable Toys & Entertainment

Small toys, games, and portable entertainment devices suitable for travel.

Home Furnishing Accessories

Small decorative items, textiles, and portable home accessories.

Liquids rule. Personal care liquids — skin, hair, and cosmetic products — are accepted only when **factory-sealed in transparent containers**. Bulk, opened, or decanted liquids are not accepted.

2 Categories at a Glance

1. Electronics

- Laptops, tablets, and mobile phones
- Chargers, headphones, and power banks
- Audio systems and speakers
- Small electronic devices and gadgets

2. Clothing and Apparel

- New and gently used clothing
- Footwear and shoes
- Accessories and fashion items
- Seasonal clothing and outerwear

3. Household Goods

- Small kitchen appliances
- Home decor items
- Portable household tools
- Small furniture accessories

4. Health and Beauty Products

- Non-prescription health supplements
- Beauty products and cosmetics
- Personal care items
- Medical devices and aids

5. Non-perishable Food Items

- Packaged foods that comply with import regulations
- Dry goods and pantry items
- Non-perishable snacks and treats
- Food items with proper labeling

3 Prohibited Items — We Cannot Ship These

- ✗ **Perishable goods** — any food or item that can spoil or expire
- ✗ **Hazardous materials** — flammable, toxic, or dangerous substances
- ✗ **Illegal substances** — any item prohibited by law
- ✗ **Customs violations** — items that do not comply with destination country regulations
- ✗ **Bulk or unsealed liquids and gels** — anything that may leak, spill, or cause damage in transit. Sealed personal care liquids in transparent containers are accepted (see section 1)
- ✗ **Fragile valuables** — items that require special handling
- ✗ **Weapons and ammunition** — any type of weapon or explosive
- ✗ **Live animals** — any living creatures or plants

Important notes. All items must comply with TSA and international shipping regulations · Customs regulations vary by destination country · Some items may require special documentation or permits · AirBaggd reserves the right to refuse items that do not meet our safety standards.
